It is that time again, the year is winding down and it is time for the Western States Bucking Bull Association Finals in Las Vegas. It has been a very competitive year and the bulls have been better than ever.



The finals will be a “Bring Your Own Rider” event. If you do not bring your own rider one will be provided if there are available riders. Bull rider entry fees will be \$150.00 (contractor \$100.00 + bull rider \$50.00)

The WSBBA teamed up with the BBOS this year and contractors may be eligible to enter two payouts given the following conditions have been met:

WSBBA ELIGIBLE CONTRACTORS

- WSBBA – Annual membership of \$115.00 paid prior to competition in any 2015 WSBBA sanctioned event
- Bull(s) being entered in Finals has competed in at least one WSBBA sanctioned event with contractor membership paid prior to competition
- Contractor has no outstanding fees, fines, or balances in WSBBA prior to entry

BBOS ELEGIBLE CONTRACTORS

- BBOS – Annual membership of \$150.00 paid prior to competition in any 2015 BBOS sanctioned event
- Bull(s) being entered in Finals has competed in at least one BBOS sanctioned event with contractor membership paid prior to competition
- Contractor has no outstanding fees, fines, or balances in WSBBA or BBOS prior to entry

DOUBLE ENTRY QUALIFIERS

- Contractor has paid WSBBA and BBOS memberships (2015) prior to competition in Mariposa, CA or Richfield, UT
- Bull(s) being entered in Finals has competed in at least one BBOS and one WSBBA sanctioned event with contractor membership paid prior to competition
